One person from your group must fill out this form to reserve any gear on our website. All floating devices come packaged with all needed safety gear and equipment. This form must also be used to rent miscellaneous river gear. Prebooked, Prepaid reservations should be made as early as possible. Many weekends will "sell-out", so reservations are taken on a first come first serve basis. Reservations with Runoff River Adventures come with full payment on our website at www.RunoffRiver.com. Once reserved, all gear is picked up at our location on the day and time the gear is to be picked up. If we are unable to fill your order we will notify you otherwise, and promptly refund your money. Day rentals are 24 hour rentals. A 10% late fee will be charged every hour equipment is late. The credit card below will be charged the full retail value if equipment is lost. The credit card below will also be charged for the restoration of any damaged equipment. To avoid the possibility of having to pay for lost or damaged gear you must book a guided trip. One person from your group must fill out this form. All credit card information is required to rent. Please pay now on our website to reserve your rental. Current rates are on our website.

1. RAFTS AND INFLATABLE KAYAKS:
\$30.00 per inch on any rips or tears. \$3,500.00 for complete loss or abandonment of Raft, \$1,000 for loss or abandonment of Kayak, inflatable kayak, or Stand Up Paddle Board, \$350.00 loss or abandonment of thwart (raft seat), \$40.00 for broken or lost raft paddle, \$75 broken or lost Inflatable kayak paddle, \$250 broken or lost kayak paddle
2. TUBES, WETSUITS, AND SPLASH JACKETS
\$150.00 for loss or abandonment of River tube, \$80.00 for loss of wetsuit, \$40.00 for loss of Splash Jacket

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, indemnify, and hold harmless, RRA, its officers, officials, agents, and/or employees, other participants, sponsors, advertisers, and, if applicable, owners, and lessors of premises used to conduct the event (Releasees), from any and all claims, demands, losses, and liability arising out of or related to an injury, disability or death I may suffer, or loss or damage to person or property, whether arising from the negligence of the Releasees or otherwise, to the fullest extent of the law.
